If any Tender is withdrawn before the expiry of minimum 360 (Three Hundred Sixty) Hours as aforesaid, the tenderer will be debarment listed and Tender Security shall be forfeited.
- 1.5 Each Tender shall strictly comply with all requirements laid down in this form and no space be kept blank.
- 1.6 The Buyer reserves the right to accept or reject any or all Tenders without mentioning any reason thereof or reserves the right to purchase any quantity more or less than those quoted for.

- 1.11 Tenders received late and or incomplete will not be accepted.
- 1.12 The local agent's commission, if any, should be mentioned separately and clearly and will be paid in Bangladesh currency on satisfactory performance of the contract at the rate of exchange prevailing on the date of negotiation of documents.
- 1.13 Goods tender must not originate from Israel. The goods must not also be shipped on a vessel flying the flag of Israel.
- 1.14 In case, the tenderers/bidders submit fake documents along with their tender and furnish incorrect/false/misleading information in their tender, the tenderer will be debarment listed and Tender Security shall be forfeited.
- 1.15 If any tenderers/bidder makes any written complaint against the decision taken on a particular case of Tender import and if, such complaint does not stand on proper scrutiny, the case is to be put up to the appropriate authority through Tender committee stating all details. In such case, the Tender committee may recommend punitive measure for debarment listing and Tender Security shall be forfeited.
- 1.16 In case, of local agent/(Principal/Seller) fails to receipt of Notification of Award (NOA)/order or fails to submit of Performance Security the buyer shall have right to forfeit the Tender Security. - 6.1 Refined Soybean Oil being an essential commodity, timely shipment and arrival of goods are the essence of the contract shipment of contracted Refined Soybean Oilis to be effected as per following schedule.
 - (a) Entire quantity of 30,00,000 (± 5%) Liter Refined Soybean Oil will be shipped within 15-10-2021.
- 6.2 After opening Letter of Credit by Buyer in favor of Seller, if there is any amendment needed by Seller, it is to be informed to Buyer within 03 (Three) days and Buyer will take necessary steps as per contract. If there is no correspondence within 03 (Three) days then Buyer will consider L/C to be functional and this period (Maximum 03 days) will not be deducted from period of shipment/ delivery. I.e. latest date of shipment maximum 18-10-2021.
- 6.3 If the Seller fails to ensure delivery as stipulated above, the Buyer shall have the right to terminate the contract and call back the letter of credit and also to forfeit the performance security even legal action may be taken against Seller as per law.

6.4 LIQUIDATED DEMURRAGE:

- If extension is required, the procuring Entity may extend delivery or shipment period as deemed reasonable. In that case the seller shall promptly notify the Buyer in writing of the delay, its likely duration and its cause. As soon as practicable after receipt of the Seller's notice, the Buyer shall evaluate the situation and may its discretion extend the Sellerr's time maximum 02 (Two) days for shipment or delivery as grace period. Ie. latest date of shipment maximum 20-10-2021 Inspite of grace period if seller fails to ship the goods, 2% deduction of payment will be applied for 05 (Five) days time extension I.e. latest date of shipment maximum 25-10-2021 and fraction will be counted as 05 (Five) days. No extension would be made after 25-10-2021. However total deduction of payment for late shipment will not be more than 2% of total value. Buyer shall have the right to forfeiture of Performance Security (PS) and to terminate the contract and/or to recall the Letter of Credit and/or other legal actions if seller fails to ship the goods within grace or extended period of shipment.
- 6.6 I/We understand that if we fail to adhere to the delivery schedule, the Buyer shall have right to terminate the contract and/or claim compensation in addition to the forfeiture of Performance Security.

7.0 TRANSPORTATION BY SEA:

- 7.3 The age of the vessel shall be restricted within 15 years. Vessel beyond 15 years of age may be used, but in that case the over-age insurance premium along with 15% VAT as charged by Buyers insurer, if any, shall be borne by Seller/Supplier. In any case the age of the vessel shall not exceed 25 years. The selected vessel must be classified in Lloyd's Register as 100A-1 or equivalent. No unclassed vessel beyond the members of International Association of Classification Societies (IACS) shall be acceptable to Buyer.
- 7.4 Part shipment is allowed but not more than <u>05 (Five)</u> installments. Trans shipment is allowed but B/L shall remain the same. The cost of first time testing for quality of Refined Soybean Oil from BSTI/BCSIR will be borne by buyer and rest of the time of cost for testing from BSTI/BCSIR will be borne by Seller.

- 7.5 In case of transportation by vessel full particulars of the vessel like, correct name, flag, year of built, name of P&I Club, Port of Registration and Registration number etc are to be supplied to the buyer by the seller at least 03 days ahead of shipment of Refined Soybean Oil.
- The first fax/e-mail notice of vessel arrival at Chattogram (Previous name Chittagong) shall give 10(ten) days second notice 72 hours and final notice 24 hours before arrival, to the following address (Dhaka Office Fax No. 88-02-8180057 E-mail tcb@tcb.gov.bd and Chattogram (Previous name Chittagong) Fax No. Office 88-031-740109. E-mail tcbctg@tcb.gov.bd If the seller fails to do so any loss incurred by the buyer on this account shall be on seller's account and the buyer shall have right to forfeit the Performance Security, besides taking other action that may be warranted by law.
- 7.7 If the ship's agent in Bangladesh fails to submit Import General Manifest (IGM) 24 hours before giving NOR or make any faulty declaration or any discrepancies arising due to negligence of shippers agent for which any loss or additional expenses are incurred by the buyer on this account shall be on seller's account and buyer shall have right to forfeit the Performance Security besides taking other action as may be warranted.
- 7.8 If the local agent of Seller in Bangladesh fails to co-operate with different organizations/agencies till the goods are handed over to Buyer's representative and any demurrage, loss or additional expenses are incurred by the Buyer on this account due to negligence of local agent shall be on Seller's account and Buyer shall have the right to forfeit the Performance Security besides taking other action as it warrants
- 8.0 TERMS OF PAYMENT:

- 8.4 Any other documents specifically wanted by the Corporation (buyer)
- 8.5 The letter of credit shall be negotiable within 21 days of relative shipment.
- 8.6 The Bank charge for establishing L/C will be on buyer's account.
- 8.7 The charges for extension and amendments of L/C will be on account of the party requesting for such extension/amendments. Add confirmation charge will be seller's account.
- 8.8 Verification of bank reference in Bangladesh and in any foreign country shall be at tenderer's cost.
- 8.9 No condition other than those stipulated in the contract shall be included in the letter of Credit.
- 8.10 The percentage of Radio activity must be within the current acceptable limit of Government of Bangladesh which is 50 BQ/kg of Refined Soybean Oilfor cesium 137. - 9.4 I/We understand that I/we shall be responsible for any demurrage, handling charges or other expenses arising from delay in the dispatch of shipping documents or incorrect preparation thereof then the cost will be seller's account and the buyer shall have the right to forfeit the amount of Performance Security for non-compliance of this instruction.
- 10.0 <u>TENDER SECURITY:</u>

11.0 PRESHIPMENT INSPECTION (CHECK OF QUALITY, QUANTITY, WEIGHT AND CONDITIONS):

- 11.1 Apart from the seller's certificate guaranteeing quality and weight of the goods delivered, the quality, specification, quantity/weight (Gross and Net.) packing and marking of the goods shall be corroborated by certificate of pre-shipment inspections. The pre-shipment inspection certificate should indicate detailed specification gross and net. Weight of goods shipped. Pre-shipment inspection and loading supervision will be done in presence of seller's representative and certificate issued by the inspection agent nominated by the buyer. PSI report by others agent (Not nominated by TCB) shall not be accepts.
- 11.2 TCB will have the right to send their representative during pre-shipment inspection / loading to see that the Refined Soybean Oilis being loaded as per specification.
- 11.3 The supplier will accord necessary facilities (warehouse and others) to the inspection agency nominated by the buyer to enable them to carry out inspection / test properly. In case the supplier fails to extend necessary facilities to the inspector or their authorized representative to perform inspection/ test properly, the cost incurred for arranging such facilities for the purpose of inspection / test shall be recovered from the supplier.
- If the supplier officially call the inspector for inspection of goods and if after arrival of the authorized representative of the inspector, fail to place the goods for inspection, the fruitless journey performed by the

- inspector shall be considered as an intervention and in such event the supplier shall be liable to pay to the inspector the cost incurred by them for the journey.

- b) Testing the entire stores with regard to quality and quantity.
- c) Maintaining of liaison with the corporation and the suppliers,

- f) Submission of test report to TCB.

11.9 OTHERS RESPONSIBILITIES OF PRE-SHIPMENT INSPECTION AGENT:

- a) The Inspector will not refuse to undertaken inspection of any goods ordered by the Buyer.
- b) In the event of non-acceptance of an inspection order, without good and sufficient reasons, the Buyer shall reserve the right to place of a fresh order with any other inspection agency and the inspector will be liable to compensate the purchaser for the loss which may result there from.
- (c) The quality inspection shall include physical, chemical, laboratory tests whenever necessary. In case of goods test/laboratory test shall be carried out on reasonable number of samples depending on the quantity of supply. In case of food items or any items test shall be conform to International standards and/or specified in the contract. Test reports and certificates shall be submitted to the purchaser immediately after the test is performed.
- (d) State inspection and testing of the entire stores with regard to performance, quality, quantity & workmanship shall have to be done as per requirement of the relevant specifications.
- (e) Inspection of packing & supervision of weighing or quantity checks as well as supervision of loading of stores shall have to be done as per terms of the contract for the stores inspected.
- (f) Inspection & supervision of loading of stores shall have to be carried out by the inspectors well in time so as to ensure deliveries within the delivery period in this contract.
- (g) Inspection of the stores after the expiry of the delivery period shall not be carried out unless expressly authorized the purchaser.
- (h) Inspection certificate shall have to be issued by the inspectors or their accredited representatives for each consignment/item inspected and accepted.
- (i) Liaison shall have to be maintained by the Inspectors with the Buyer.
- (j) Partial shipment may be allowed by the Buyer where demanded by the Seller's to their convenience. A clause will, however, be incorporated in supply/purchase contract that the supplier/manufactures abroad shall provide to the inspectors or to their authorized representatives all facilities for carrying out inspection & witnessing tests as provided in the specification governing such suppliers or in conformity with the normal trade practices.
- (k) The inspection agent shall entirely responsible for successful execution of the order/contract in all respects and in accordance with terms and conditions specified therein. The terms and conditions of Tender instructions to the renderers and specification will constitute as an integral part of the contract.

In spite of this clear provision in the purchase order if the supplier/manufacturers abroad do not provide such facilities, the inspectors shall have to inform the purchaser and after obtaining his permission, they shall have to make their own arrangement for carrying out inspection or test as stipulated in the supply/purchase contract involved. In that case, the actual expenses on that account will be reimbursable to the inspectors on production of original documents and will be recovered by the purchaser from the suppliers concerned. Inspectors will, however, have to make efforts to reduce such expenses to the barest minimum.

11.10 SELLER'S RESPONSIBILITY DURING INSPECTION:

i) PACKING AND MARKING:

- a) Responsibility for proper packing: The supplier will be held responsible for the stores being sufficiently and properly marked for transport by rail, road and sea, so as to ensure their being free from loss or injury on arrival at their destination. The packing of the stores shall be done by and at the expense of the supplier.
- b) If the stores are not packed and marked in accordance with the instruction or in case where the packing materials are delivered separately and they are not in accordance with those instructions are not marked according to them consignment are liable to be rejected by the Inspector whose decision as to the sufficiency or otherwise of compliance with the instruction shall be final. Re-packing, if required by the inspector before onward dispatch shall be carried out by the supplier within a reasonable time of the deed and therefore, be carryout the Inspector at the cost of the supplier

ii) DELIVERY:

- a) The supplier shall allow all reasonable facilities to the Inspector including free and full access to his works and all records having a bearing on the progress of the deliveries against the contract.
- b) Notification by the supplier: Suppliers will notify the PSI Company/Inspector about the readiness of the concerned stores for inspection and test 10 (Ten) days in advance. In any case the notified date of readiness should be well in advance so that inspections and tests are completed before the date of shipment. The corporation is responsible for immediately notifying the Supplier if readiness of the stores is to be retarded or deferred.

iii) <u>FACILITIES FOR TEST AND EXAMINATION:</u>

- a) The supplier shall at his own expenses afford the Inspector all reasonable accommodation (warehouse) and facilities for satisfying himself that stores are being or have been manufactured in accordance with the particulars and for this purpose the Inspector shall have full and free access at any time during the contract to the supplier works and may not withstanding any contractual terms to the contrary require the supplier to make arrangements for the store or any part thereof to be inspected at the suppliers premises or at any other place and the supplier shall reserve a similar rights as regards any sub-contract he may make.
- b) The supplier shall pay all costs connected with such tests and provide without extra charge, all materials tools labor and assistance or every kind which the Inspectors may consider necessary for any test and examination other than special –independent test which he shall require to be made on the suppliers premises for making the tests the supplier shall bear the cost of carrying out such test elsewhere.
- c) The supplier shall also provide and deliver free of charge at each place as the Inspector may direct such materials as he may require for test by chemical or other analysis or intended testing machines or means commonly in use according to the nature of the stores. In the event of such tests being unsatisfactory and resulting in leading to the rejection of the stores concerned the cost of the tests will be borne the supplier. Such cost will be assessed at the rates charged by the laboratory-testing firm concerned for work for private firm and individuals.

iv) POWER OF THE INSPECTOR:

The authority to certify performance; The Inspector shall have power before any stores or parts thereof are submitted for inspection to certify that they cannot be in accordance with the contract owing to the method of manufacture not being satisfactory or to reject any stores submitted as not being in accordance with the particulars.

v) REJECTION

- a) The Inspector may reject the whole consignment Tendered for inspection if after inspection of such portion thereof as he may decide at his discretion he is such satisfied that the consignment is not up to the specification.
- b) If any store is rejected as aforesaid then to allow the contractor to re-submit stores in replacement and the contractor will bear all costs on such replacement without being entitled to any extra payment without prejudice.

11.0 INSPECTION OF QUALITY, QUANTITY, PACKING, MARKING WEIGHT E.T.C):

11.1 AT SELLER'S GODOWN

The Buyer shall have the right of checking the quality, quantity, packing, marking, weight (Gross & 11.1.1 net) of White Refined Sugar packed in export standard/export worthy new and sound poly lined jute or polypropylene bag of 50 kg. Such checking of goods shall be carried out at the Seller's godown in presence of Seller or Seller's representative. For these purpose, Seller will preserve White Refined Sugar in a good condition godown and no others goods is to be preserve in the same godown .The Said godown will be locked and key. Before deliver the goods the sample will be drawn by Seller and Buyer's representative.
